October 25, 2018 – Board of Health Meeting Minutes

The Branch-Hillsdale-St. Joseph Community Health Agency Board of Health meeting was called to order at 9:02 a.m. by Chairman, Allan Balog, with the Pledge of Allegiance to the Flag of the United States and roll call as follows: Allan Balog, Don Vrablic, Kathy Pangle, Terri Norris, Mark Wiley, and Bruce Caswell.

Also present from BHSJ: Rebecca Burns, Dr. Vogel, Theresa Fisher, Yvonne Atwood, Laura Sutter, and Jeff Macklin.

Ms. Pangle moved to approve the agenda with support from Ms. Norris. The motion carried.

Ms. Norris moved to approve the minutes from the previous meeting with support from Ms. Pangle. The motion carried.

Public comment:

- Rebecca Olds and Quinn White from Southern Michigan Bank & Trust presented a gift of new CPR Manikins with a value of \$1,500.00 to the Agency.
- Orlando Todd, MDHHS Director of Office of Local Health Services presented the Accreditation Certificates for Cycle 7 Accreditation. The Agency received full Accreditation with Commendation and a certificate for Quality.

Rebecca Burns, Health Officer, reviewed her monthly report. Items discussed: CPR Manikin Gift, Accreditation Certificate Presentation, Meridian Health Plan, PFAS Testing, Health Promotion & Education Updates, Mosquito Borne Diseases, Staff Vacancies, Health Officer Evaluation, Annual Year End Close, and the Hepatitis A Outbreak.

Dr. Vogel, Medical Director, reviewed the Medical Director's monthly report. This month's reports covered Proctober, the focus on men's health, and Acute Flaccid Myelitis (AFM), which is an emerging disease which affects the brain and nervous system.

Health Officer's Report to the Board of Health for December 13, 2018 Prepared by: Rebecca A. Burns, M.P.H., R.S.

Agency Updates

AAA 3C – I am working with St. Joseph County officials on the annual local allocation to the Area Agency on Aging. At the November meeting of the St. Joseph County Commission on Aging Advisory Board, the board members were told that the COA obligation to the AAA3C could be met by "match". This was true with regards to the grant funds that the COA receives from the AAA3C. But it left out that the AAA3C is also funded by the county in the form of a local appropriation. The local appropriation is used by AAA3C for its grant matching obligation and to help pay for operations. Neither Laura nor I had any indication that the county was considering not appropriating the county allocation. An historical check shows a previous county administrator directing the COA director to put the county allocation in the COA budget; and as far as we can tell this has been the long-standing practice. Laura was informed of the COA Boards action and since then we have met with the COA's executive director and the county administrator. At this time, I have been informed that it is likely the county will pass the budget without a county allocation for AAA3C as that is what was forwarded from the COA Advisory Board. I have been informed that St. Joseph county may consider taking up the county allocation to the AAA3C in January. Without the county allocation from St. Joseph county, the budget we prepared is no longer accurate. Everything within the AAA3C operation and subsequent budget will have to be analyzed and decisions made about how to operate. I have been informed that Branch County intends to approve the county allocation along with the increase in allocation that was requested earlier in 2018.

Finance Committee Discussion Items – Several items were brought to the Finance Committee for review and are being brought up in today's meeting. These include:

- Budget Amendment The budget amendment presents a balanced budget assuming that Branch and St. Joseph counties will provide the same county allocation to the AAA3C as for FY18.
- Employee Compensation Proposal to provide the employees of the Agency with an increase in the hourly rate was discussed. Compensation increased in FY18 by 1%. For FY14 through FY17, wages remained stagnant. In FY13 a one-time 50 cent increase was given to all employees. During FY09 through FY12 wages remained stagnant. Discussion also included having the Agency contract to have a Comprehensive Compensation Study completed. The document we use today dates to 1984.
- Investing additional funds in Class Account We have the County Health Plan funds in the class account and the return is much better than a savings account while keeping the funds liquid.
- Branch County Community Health Needs Assessment (CHNA) Request by Promedica to share in the cost of the CHNA. Requested donation of \$1000.00. Our Agency has previously donated staff time toward this project. The Agency would not have staff time invested but would reap the benefits of the final report and data generated. We utilize the data for targeting our Maternal Child Health grant dollars and to stay in compliance for accreditation.

LARA's Legal Division of the Bureau of Medical Marihuana Regulation – I recently learned about medical marihuana operation and oversight grant funds available to counties for education and outreach programs relating to the Michigan medical marihuana program. These funds cannot be used for law enforcement purposes. However, the Health Educators in our Agency could provide the services.

New Database Updates –

- HealthSpace: We are in the initial testing phase of the install. Go live date is February 4th.
- **Nightingale Notes:** Staff training kicks-off January 10th. The Agency has a fully executed contract with UPHIE (a health information exchange in Michigan that will facilitate the connection with MICR). Go live date is April 8th.

Meridian Health Plan – After a long and thorough investigation, we have determined that the payback to Meridian Health Plan for receiving the PCP-IPP payment in 2014 in error is \$12,515.09. I reported at the last meeting that there was a discrepancy in the amount the state showed needing to be returned. The state records did not go back far enough and that was the reason they showed a lower amount. Our staff reviewed the billings we made versus the check that was received going line-by-line, patient-by-patient, and now concur with the original requested amount to be returned. I have approved the payment for processing and it will be charged to the Immunization Reporting Unit. This line will be overspent until a budget amendment is made.

PFAS Testing – The sample results for municipal and Noncommunity water supplies are back and are nearly all "Not Detected". This is great news! There were no samples in the 70 ppt or higher category which would have triggered immediate public health action. One sample tested in the 10-69 ppt range and will receive routine follow-up testing. The state did add Noncommunity supplies labeled as "Daycares" and those samples are being taken now.

Health Promotion & Education Updates – The Agency's HPE team has written 11 news releases for local media and posting on our website since the last Board of Health meeting. These include:

The Agency also attended local events and installed a number of car seats for those in need.

Mosquito Borne Diseases – I've attached the information graphic on Arbovirus activity in Michigan for November 29, 2018. In addition to the EEE positive human case in Allegan County, there were also two deer that have tested positive in Cass and Barry Counties. This will be my last update on this topic until next year. We will be receiving grant funds to again implement the mosquito surveillance project for summer 2019. We will again be looking to identify the Aedes mosquito that carries Zika Virus. In addition to mosquito collection, our EH staff will also be doing tick collection. Ticks can carry Lyme Disease and other bacterial diseases.

Staff Vacancies/New Staff – There are currently no positions posted. Individuals that have joined the Agency include Mary Mercurio, Hillsdale Clinic Coordinator; Tia Spratt, Hillsdale Clinic Clerk Tech part-time; Barb Keith, Food Service Sanitarian; and Tina Lutz, CSHCS Representative part-time.

Annual Audit/Year End Close– The auditors will be on-site January 14-16, 2019. We are still waiting to hear if Branch and St. Joseph Counties will provide the requested local appropriation increase, while Hillsdale County voted and approved an increased amount. Our audit firm, Stevens Kirinovic and Tucker P.C. are merging with Maner Costerisan effective January 1, 2019.

Area Agency on Aging Association – I would like to suggest that Laura Sutter's name be put up as the AAA3C nominee to the Board of Directors.

Agency's Staff Development Day – On November 12th, the Agency closed and all staff reported to the ProMedica Conference Center for a full day of staff development and training. Topics covered included human trafficking, Resilience Video for adverse childhood experiences, mandatory reporting requirements, MCDC, team building and agency awards. We also discussed how the currently closed Health Care Savings Plan could be reopened.

Snow Plow Sealed Bids – The Agency put out a request for sealed bids for the snow plowing at the Three Rivers building. The Agency entered into a contract with a local vendor that will result in a reduction in cost per plow of \$15 to \$25 depending on the amount of snow. The total savings depends on the amount of snow we receive over the winter.

Legislative Updates - HB 5752 is moving in lame duck as of the typing of this report.

Hepatitis A Outbreak – As I have been reporting, Michigan is in the midst of a serious Hepatitis A outbreak. Current case count as of December 5, 2018 is 908 with 729 hospitalizations and 28 deaths. The case count continues to climb. The Agency continues to put special emphasis on increasing our vaccination rates for adult Hep. A, especially of the high-risk individuals. Hepatitis A vaccination is safe and effective. The following individuals should get the HAV vaccine:

- Persons who are homeless.
- Persons who are incarcerated.
- Persons who use injection and non-injection illegal drugs.
- Persons who work with the high-risk populations listed above.
- Persons who have close contact, care for, or live with someone who has HAV.
- Persons who have sexual activities with someone who has HAV.
- Men who have sex with men.
- Travelers to countries with high or medium rates of HAV.
- Persons with chronic liver disease, such as cirrhosis, hepatitis B, or hepatitis C.*
- Persons with clotting factor disorders.

Birds testing positive for West Nile virus infection

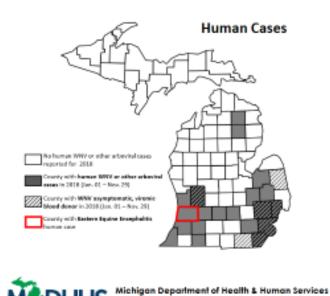


Human cases of West Nile virus or other arboviruses reported

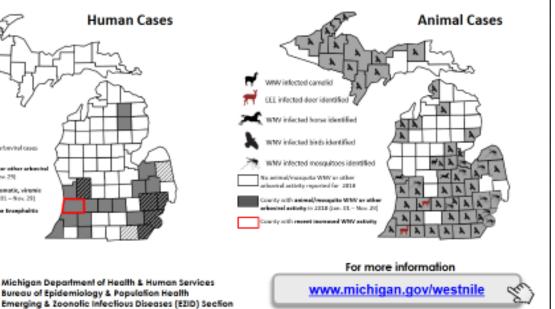

Current Highlights

- The Michigan mosquito season has ended. However, travelers to warm weather destinations should continue to protect themselves from mosquito bites.
- West Nile virus sickened at least 104 Michigan residents, resulting in many hospitalizations and eight fatalities, the most since 2012, when 202 cases and 17 deaths occurred.
- Routine testing of the blood supply identified WNV in 12 Michigan blood donors.
- WNV infected at least two horses (Muskegon, Gratiot), and 1 alpaca (Isabella).
- An Allegan County resident and two whitetailed deer from Cass and Barry Counties were infected with Eastern Equine encephalitis virus (EEE).

Medical Director's Report to the Board of Health H. Lauren Vogel, D.O., M.P.H. December 2018 - Alzheimers or Oldtimers Disease

About 40 per cent of people over the age of 65 experience some form of memory loss. Memory loss not associated with an underlying medical illness is known as age-associated memory impairment and this is considered a normal part of the aging process. ¹ Dementia is a medical illness of several causes that can include Alzheimer's disease, depression, hypothyroidism, stoke or drug related dementia. It's important to distinguish age related mental change from disease because most of the medical illnesses have treatment opportunities that can improve symptoms or delay the progression of the disease.

Age Related Memory Loss	Alzheimer's Disease
Not being able to remember the name of an acquaintance	Not recognizing or knowing the names of close family members
Occasionally have difficulty finding words	Frequent pauses and substitutions when finding words
You are worried about your memory but your relatives are not	Your relatives are worried about your memory, but you are not aware of any problems

Here are some examples of aging verses dementia related disease: ¹

Alzheimer's disease (AD) is the most common form of dementia. Symptoms usually begins after age 60 with mild memory loss. AD is a progressive disability that leads to the patient's inability to interact with their environment. It is the 6th leading cause of death among US adults and the 5th leading cause of death among adults aged 65 years or older. ³

The cost of care for the Alzheimer's patients in the US exceed several billion dollars yearly. The disruption in the family unit caring for the Alzheimer's patient is significant. Both of these issues are significant public health issues.

Evaluation allows for a definitive diagnosis and the institution of medical care that can delay the progression of the disease and give the patient and their family more quality time together. Testing also allows for the exclusion of dementia and this is reassuring to the patient and his family.

The Montreal Cognitive Assessment (MoCA) was designed as a rapid screening instrument used to identify persons with mild cognitive dysfunction. It was developed by Z. Nasreddine MD in 2004 and has become a standard screening exam for dementia assessment. Scoring is easy when directions are followed correctly. The test is reliable and allows for early identification of those persons with mild symptoms when treatment options are most beneficial. Special medical expertise is not required to give or interpret the test. MoCA is not an intelligence test but is a measure of cognitive function. Results of an abnormal MoCA should be followed by referral for further testing and institution of treatment.

MoCA is part of a screening exam that should be completed for any person with possible cognitive derangement. Repeated testing can demonstrate failing function over time. Directions for the test and for scoring is available on line.⁵

The pool invests in U.S. Treasury obligations, federal agency obligations of the U.S. government, high-grade commercial paper (rated 'A-1' or better), collateralized bank deposits, repurchase agreements (collateralized at 102% by Treasuries and agencies), and approved money-market funds. The credit quality of the pool is excellent, with greater than 50% of the portfolio invested in securities rated 'A-1+' and the remainder in 'A-1' rated securities. The portfolio's weighted average maturity to reset (WAM(R)) is kept under 60 days, which further helps to enhance liquidity and limits market price exposure. Portfolio securities are priced to market on a daily basis.

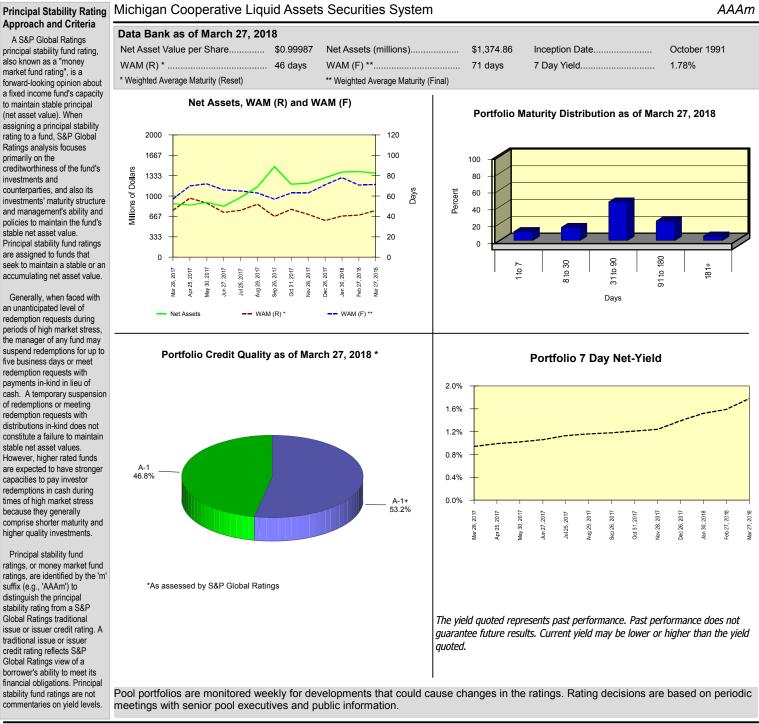

Communicable Disease: (CD-TB-HIV-STD):

- Flu reports are still sporadic which is good. We have given 1,607 flu vaccinations this season as compared to 1,033 this time last season.
- Pertussis is still going on in all three counties, still mostly Amish Communities.
- So far, we have not had any connections to the Romaine lettuce E-Coli 0157:H7 outbreak. There are 32 cases in 11 states. Seven in Michigan. (1 in Cass, 2 in Macomb, 3 in Oakland, and 1 in Wayne County. The FDA and CDC feel the illnesses are likely linked to romaine lettuce grown in regions of northern and central California this fall. Canada is also involved with a similar outbreak. The FDA conducts traceback activities like reviewing shipping records and invoices to where the ill people are located. They have narrowed it down to 6 counties in California, but not a specific farm, processor, shipper or distribution center. At this time, the FDA recommends consumers not eat romaine lettuce grown in Monterey, San Benito, San Luis Obispo, Santa Barbara, Santa Cruz, and Ventura. As a result of the investigation, a recommendation has been made for all romaine lettuce to be labeled with a harvest location and harvest date, and/or labeled as being hydroponically or greenhouse grown. You do not need to avoid romaine lettuce grown in Yuma, Imperial County, Riverside County, Florida, and Mexico or grown hydroponically or in a green house. Do not use any romaine lettuce that does not have the proper labeling.

Immunizations:

- We have been working hard in the Amish Communities to come in for Pertussis vaccinations.
- We are still doing Hep A Clinics in the Communities.

Women, Infants, and Children's Nutrition Program (WIC):

- ✤ WIC participation is about the same at 4100+.
- Our new WIC Coordinator and Hillsdale Clinic Coordinator, Mary Mercurio, is doing a wonderful job.
- We have our positions filled! Now we need to get them through orientation and job training.

Children's Special Health Care Services (CSHCS), Lead, and Hearing and Vision:

The number of high lead level cases remains about the same. They see about 3-5 families a month. The Hillsdale nurse is going out on her first visit next week. We now have a trained lead nurse in each office.

We are happy to announce that we filled our vacant food sanitarian position back in late October. Barb Keith has taken the position and has been working very hard towards completing her training. Barb is a St. Joseph county resident who comes to us with a great deal of restaurant management experience. She also has a Nutritional Science degree and is currently working on a Master's of Applied Science in Public Health. Barb has completed her 25 joint inspections



with Joe Frazier and is now working on completing 25 more inspections that she will conduct alone with Joe's review. We are very happy to have Barb on our staff, she is very excited to be working for the agency. Getting a job working in public health has been a goal of Barb's since working as a restaurant manager. The restaurant's where she worked as a manager were in our jurisdiction and she attributes her passion for working in public health from the education and mentoring she received from our staff (Joe Frazier and Rob Stauffer).

Well & On-Site Sewage

The (Type II) Non-Community Water Program had its annual review last month. I am pleased to say that we passed the review with flying colors. The Type II program has responsibility for the regulation of the smaller public water supplies that include facilities such as restaurants, campgrounds, small factories and churches. One of the most important duties include tracking each establishment to ensure they are taking all required water samples and following up when they don't take the samples or they have a sample out of compliance. One of the big challenges within the program has been gaining compliance on water sampling requirements. In 2016 the EPA mandated a new sampling protocol that increased sampling requirements from once per year (if a facility had a good sampling record) to 4 times per year and in some cases, the sampling could be increased to monthly. This increase in sampling triggered an abundance of monitoring violations (facilities not sampling as required). In fiscal year 2016 we had monitoring violations in 51% of our facilities, last year, the number of violations went down to 34% and this year it was 13%. This sharp decline can be attributed to the hard work of David Wagoner, our Type II coordinator.

General Programs

We continue to monitor our PFAS water results from the three counties. To date we have received 76 results of the 78 well tested, there is one well in Hillsdale County that has yet to be tested. There have been 4 wells that had results in the 0-9 ppt range (considered background levels only and not of health concern). We had one well that tested in the 10-69 ppt (33 ppt) and this well will be monitored further will a quarterly testing schedule. All the rest of our results have been not detected. The state recently decided to expand the sampling to include daycares and head-start site that have their own wells. We have only received one result from these samples and it was also not detected.

Updates:

- 1. St. Joseph County's Interdisciplinary Team met on December 5th. Updates from around the state were made by Ron Tatro of Elder Law of Michigan. He noted that StJoe County is one of a growing number of Teams who are collaborating and making significant progress in serving those who are vulnerable and applauded our great success! We also met the Jail Diversion staff person from StJoe CMH who is beginning a new training program for law enforcement/correctional officers/first responders that could also support other human service professionals it's called "Managing Mental Health". The group also discussed development of an Elder Death Review Team and other outreach efforts for the coming year. The group will be meeting more frequently, as well, thanks to VOCA staff who have dedicated time for the Team. Branch County's efforts are not far behind and gearing-up as well!
- 2. Community Living Program updates: We continue to be extremely busy... The waiting list is currently (as of the time this report was written) at 23 people, some of whom have been waiting over 150 days. Those in greatest need for CLP, on average, wait for 75 days unless they're referred directly from Adult Protective Services. We are doing our best to keep up with referrals coming in and assisting people access community supports and services.
- Medicare/Medicaid Assistance Program updates: Deanna, our MMAP-trained Regional Coordinator, has been spending 2 days per week at our local MMAP Sites (each County's COA) to assist with Open Enrollment for Medicare Part D. In addition, she's held more appointments back here at the AAA office and with individuals in their home as they're not able to get to the Senior Center for appointments.
- 4. VOCA Services to Victims of Elder Abuse Grant updates:
 - a. We are working with each county's established crisis lines to develop afterhours/weekend/holiday coverage to support victims.
 - b. Constitutional Victims' Rights Notices were sent to all law enforcement agencies, first responders and human service partners across the region. The CVRN will be updated once crisis line protocols and processes are in place.
 - c. Survey tools are being drafted to begin gathering outcome and satisfaction data, as required by the grant.
 - d. 13 individuals have/are receiving services from Elder Abuse Victim Specialists
