Agency Updates

Area Agency on Aging 3C 2020 Multi-Year Plan – The multi-year plan was presented to the Michigan Commission on Services to the Aging last Friday and has been approved. The Program, Policy and Appeals Committee met on August 14th to review the bids for services and have prepared recommendations for the full Board's consideration at today's meeting.

Medical Marihuana Education Grant – It seems we have just started, but we are wrapping up the Medical Marihuana Education Grant at the end of this month as we are required to submit a final report and request for reimbursement by September 15th. The lock boxes are out in the community now at a number of local service providers.

Medicaid Cost Based Reimbursement – I have no new information at this time.

New Database Updates -

- **HealthSpace:** Environmental Health continues to work with the vendor on getting ready to go live with the on-site sewage and well water programs.
- **Nightingale Notes:** Champ software is now a MICR approved vendor! This is a huge step forward for our vendor and we are thrilled to have that hurdle behind us. The Agency will begin using the software for our Immunization program beginning September 1st. We are using a clearing house called Availity to stream line our billing that works in conjunction with our new software and we are thrilled to be putting it to use as the flu season begins. The STD and HIV programs are using the software now and we have begun to utilize it for the lead program.

Health Promotion & Education Updates – The Agency's HPE team has written 3 news releases for local media and posting on our website since the last Board of Health meeting. These include:

- Immunizing for School: (8-14-2019)
- August is Breastfeeding Awareness Month: (8-15-2019)

The HPE Team maintained an Agency booth at the Branch County Fair, attended the Huss Future Fest in Three Rivers, Hillsdale Clinic Team held a Saturday Summer Clinic, and in Constantine a Car Seat Check was held that our Breastfeeding Peer attended to talk with residents about our programs. The WIC Facebook page has received a number of posts also. Paul was interviewed by Fox17 News about an issue with a restaurant in Bronson.

Staff Vacancies/New Staff – There have been no new staff started since my last report. The AAA3C has had several staff move on to new opportunities and Laura and her team are well on their way to filling those positions. By next month, I will be able to share these new staff members with you.

Comprehensive Compensation Study – The Agency Directors and I met individually with the consultant putting together our study this week to provide him with more information and to clarify questions he had. This project is on target for presentation at the September 26th Board of Health meeting.

Legislative Updates – None at this time.

Hepatitis A Outbreak – As I have been reporting, Michigan is in the midst of a serious Hepatitis A outbreak. Current case count as of August 14, 2019 is 918 with 737 hospitalizations and 28 deaths. There has not been an increase in cases since my last report. Cass County still remains as the only "outbreak county" in Michigan. The Agency continues to put special emphasis on increasing our vaccination rates for adult Hep. A, especially of the high-risk individuals. Hepatitis A vaccination is safe and effective. The following individuals should get the HAV vaccine:

- Persons who are homeless.
- Persons who are incarcerated.
- Persons who use injection and noninjection illegal drugs.
- Persons who work with the high-risk populations listed above.
- Persons who have close contact, care for, or live with someone who has HAV.
- Persons who have sexual activities with someone who has HAV.
- Men who have sex with men.
- Travelers to countries with high or medium rates of HAV.
- Persons with chronic liver disease, such as cirrhosis, hepatitis B, or hepatitis C.*
- Persons with clotting factor disorders.

Medical Director's Report to the Board of Health H. Lauren Vogel, D.O., M.P.H. July 2019 - Lime disease

Not to be confused with Lyme disease, lime induced photodermatitis is a pruritic blistering skin reaction following exposure to lime juice in combination with sun exposure. The skin reaction, also known as margarita photodermatitis, is caused by exposure to a chemical (furocoumarins) found in limes and other citrus fruit including oranges, grapefruit and lemons.¹

Not only is your margarita dangerous, your bloody mary can also cause skin rash due to that stalk of celery which also contains furocoumarins.² Other common plants that can cause blistering skin reactions after sun exposure include figs, celery, carrots, fennel, parsley and dill. The reaction requires initial skin exposure to the skin, juice or leaves of the offending plant and then exposure to sunlight.

The skin reaction can be as mild as erythema or as severe as blistering of the skin under the contact area. Symptoms usually appear one or two days after the combination exposure. The cause is often misdiagnosed because the exposure to the plant and then sunlight are not recognized as the culprit. Even at the clinician's office the skin reaction may be diagnosed as sunburn, allergy or a nonspecific contact dermatitis. A thorough history will usually suggest phytophotodermatitis as the correct diagnosis.

The skin reaction is characteristic with streaks and irregular shaped lesions noted. Hyperpigmentation often occurs after one to two weeks and may last for months. The lesions do not usually itch initially but pruritis develops after 24 hours post exposure.³ Scarring is uncommon but does occur especially if the blistered skin becomes infected.

The most effective treatment is prevention. Washing with soap and water after contact with plants known to cause photosensitivity and before sun exposure will prevent the solar reaction. Gardeners should wear gloves when handling vegetables. The lemon or lime peel or celery stalk that has touched the hands or face can precipitate a reaction that can be prevented if the face, mouth and hands are washed before sun exposure.

There is no specific care for the skin reaction. Supportive treatment with cold application, lotions and covering the lesions may be effective. Time will be the only modifier if hyperpigmentation occurs.

Personal Health & Disease Prevention June Meeting 2019

Communicable Disease: (CD-TB-HIV-STD):

Measles Update:

From January 1 to August 8, 2019 the number of measles cases are up to 1182 in now 30 states. Ten cases just from the previous week. More than 75% of the cases this year are linked to the outbreaks in New York or New York City.

Swine Flu and Fair Season:

- 1. *Jackson County Fair:* MDARD identified pigs at the Jackson County Fair that tested positive for swine flu on Friday, August 9, 2019. The fair was scheduled from August 4-August 10.
- Eastern Michigan State Fair: On July 31, 2019, the Lapeer County Health Department (LCHD) issued a press release regarding swine flu confirmed in pigs at the Eastern Michigan State Fair in Imlay City. The fair took place from July 23-27.
- **3.** *Fowlerville Family Fair:* On July 27, 2019, the Livingston County Health Department issued a <u>press release</u> regarding swine flu confirmed in pigs at the Fowlerville Family Fair. The fair was held from July 22-27.
- **4.** Each local health department, in coordination with fair boards and MSU extension, is reaching out to exhibitors and their families who participated at each fair that may have been in close contact with the infected pigs.
- 5. Health care providers should watch for patients with respiratory symptoms who also report exposure to swine or visited the fairs. Swine flu testing is available through the MDHHS laboratory. Commercially available tests cannot distinguish between seasonal flu and swine variant viruses.

Ebola:

- 1. From August 1, 2018 to July 28, 2019, the WHO reports 2,671 confirmed and probable cases, including 1,790 deaths.
- 2. On July 18, the WHO Director-General declared a Public Health Emergency of International Concern (PHEIC). Factors affecting the outbreak include population movement in highly densely populated areas; weak infection and prevention control practices in many health facilities; complex political environment; continued reluctance in the community; and the ongoing unstable security situation, which led to the recent murders of two community health workers.
- 3. An outbreak of Ebola is in the North Kivu (Kivu Nord) and Ituri provinces in the northeastern part of the Democratic Republic of the Congo (DRC).
- 4. North Kivu and Ituri provinces are among the most populated in DRC. These provinces share borders with other countries (Rwanda, South Sudan, and Uganda) with frequent cross-border movement for personal travel and trade. The provinces have been experiencing a prolonged humanitarian crisis and deteriorating security, which are limiting public health efforts to respond to this outbreak. The US Department of State has identified this part of the country as a "do not travel" zone because of crime, Ebola, and kidnapping.

Immunizations:

We are gearing up for back to school vaccinations. Hillsdale held a clinic on Saturday and saw at least 10 people. Branch went to Union City High School and spent the day there giving vaccinations.

<u>Women, Infants, and Children's Nutrition Program (WIC)</u>: Participation reports not working this month. Will hopefully be working in September and the numbers will be added next month.

Children's Special Health Care Services (CSHCS), Lead, and Hearing and Vision

CSHCS received a \$10,000 dollar grant from MDHHS – Family Center to use for 7 different outreach and advertising activities to benefit the clients and the program.

Food Service Sanitation

The Branch County Fair took place earlier this month and as I reported last month, we participated in a MDARD pilot program to inspect the food facilities this year. There was a total of 37 food vendors present and event went very smoothly. We brought in our staff from all three counties and we were able to complete all of the inspections in one day. The staff at the fairgrounds was



extremely helpful, we also had an MDARD staff member along to help us understand the processes that their agency has used for the fair inspections in the past. One of our biggest concerns coming into the fair was getting the vendors to apply for the food permits with our agency instead of the MDARD, but we didn't have any issues in that regard. Overall, it was a very smooth transition and we will be in communication with MDARD on the possibility of continuing the inspection of this fair in the future.

Well & On-Site Sewage

As part of the initial statewide testing for PFAS in municipal water systems throughout the state, our agency had one water supply that with a result that was under the health limit but higher than what is considered background. Because of this result, that supply was put on a schedule for quarterly sampling to monitor the PFAS levels. We recently received the results from the follow-up sample and the concentration had increased slightly but was still under the health limit. That supply will continue to be monitored in future months to ensure it stays below the health limit.

General Programs

Our staff has been working hard to complete all the summer program inspections which include: campgrounds, children's camps, swimming pools, septage hauler vehicles and septage disposal sites. The majority of these inspections have been completed with the exception of a couple of septage haulers and two campgrounds (St. Joseph County Fairgrounds and Hillsdale County Fairgrounds) that can't be done until next month at the time of the fair.

Our work in the Vector-Borne Disease Project (grant project funded by DHHS) is coming to an end this month. We hired 3 student interns to perform the work in the grant project and they have done an excellent job. The grant required mosquito trapping and identification, tick drag collection and identification and the option of doing community outreach/educational events. Along with all the required mosquito and tick collection and identification our interns did a total of 7 community outreach and educational presentations throughout the three counties.
