Agency Updates

BHSJCHA Team WORK - I remain immensely proud of our team at BHSJCHA and their dedication to public health and the citizens in Branch, Hillsdale, and St. Joseph counties. I also want to emphasize the strength that comes from the fact that we are a District Health Department. The combining of these three counties has allowed for a team of nurses not just one or two that a small county health department would have. The three counties support each other, there are no "dividing lines" between Branch and St. Joseph counties or Branch and Hillsdale counties. All members of this team work all three counties and share in the workload. Each county receives much in return by virtue of the fact that we work collaboratively.

Updated Programming Activities - We continue our WIC program remotely with clients. Both supporting our existing clients and bringing on new ones. The WIC numbers have grown substantially throughout this crisis because so many families with young children are hurting. We did a test run in our Immunization program last week and this week in our Coldwater office. Both went well and we will begin next week also offering immunizations in Hillsdale and St. Joseph counties. Many kids have fallen behind in immunizations due to COVID-19 and we need to work to get them caught up. The CSHCS nurses are beginning to work to assist clients with their doctors visits and appointments now that specialists are again starting to see patients. Environmental Health is mostly back to work, as contractors need permits to continue work. The food sanitarians are issuing temporary food permits and investigating complaints. No routine in-person food service inspections are ongoing though at this time.

All BHSJCHA team members are back in the office Monday through Friday during normal hours. We are staffing the office on the weekends from 8 am to noon both days and offering those hours to anyone in the Agency that has taken the training and is interested. The work done on the weekends includes case investigation and contact tracing.

At this point, I am looking to the first Monday after the 4th of July as a possible date to reopen our offices to the public without requiring an appointment. This final decision will rest on how COVID-19 infection rates are over the next month.

Local Health Officer Orders: I want to keep this on your "radar". As Michigan continues to open up, there may be a need to institute a local order to protect the health and safety of residents in one or more of our three county area.

Board Education Session: Today's educational session will focus on Public Health Finance.

Strategic Planning: This is at a total pause due to COVID-19.

Hepatitis A Outbreak Carry-over Funds: As I explained last month, we were awarded \$25,000 in Hep A Outbreak carryover funds. We budgeted to use these funds to replace the aging vaccine refrigerators in Coldwater and Hillsdale and to purchase some portable vaccine refrigerators. We have bids in and the larger vaccine refrigerator that we want to put into our Coldwater office which holds the majority of our vaccine is over \$5000.00. We would ask that the Board of Health authorize us to purchase this unit using the grant funds that have been set aside for this purpose.

Health Department Leases (keeping these in my report but there has been no change)

20 Care Drive, Hillsdale, MI I am keeping this in my report until a final decision has been made as to how to proceed after August. As I reported in December, the final payment for the mortgage on the building we occupy in Hillsdale will be made in August 2020. I understand that the Hillsdale County Commission has had some discussion regarding this building and potentially adopting an agreement similar to the one the Agency has with St. Joseph County.

570 Marshall Road, Coldwater MI – I reached out to County Administrator Bud Norman to request an extension through October 30^{th} . The extension of our current agreement was accepted by the county and has been signed by both parties. Administrator Norman and I have an appointment scheduled in mid-June to get back to working on the new agreement.

1555 E. Chicago Road, Ste. C, Sturgis, MI – There has been no movement with this project due the social distancing measures put in place in Michigan. I have reached out to the landlord to set a date to discuss further.


Health Promotion & Education Updates –Our other health educator, Kelley Mapes, has been continuing work with the Medical Marijuana grant and messaging out about the WIC program and how to sign-up for nutrition benefits. There have been several press releases sent out, mostly focused on COVID-19.

Budget Amendment – We are currently working on the budget amendment and will soon start work on the FY21 proposed budget. These are both anticipated at the June meeting.

COVID-19 Update – The outbreak at the Hillsdale Medical Care Facility seems to be under control and we are thankful for the measures put in place by the administration at that long-term care facility. The prisons received another round of testing. Sturgis seems to be home to a number of our newer cases with most cases having ties to their workplace where infection started and in some cases was brought back to a family. We have put out a special message to the Hispanic community jointly with Sturgis Hospital to try to reach that community better.

Every day Monday through Thursday at 8 am I meet with the Directors and Supervisors to discuss the cases, epi-links, community and business issues, our Agency issues, and anything else that comes up. These sessions are not only critical to our success as we navigate this crisis but also therapeutic to this group. On Fridays the meeting turns into an all Agency opportunity for updates and a question and answer session.

At this point we are continuing to work with those that are positive or are close contacts to try to stop further transmission. With Indiana and Ohio reopening faster than Michigan, it is becoming increasing difficult for us to message effectively to people to Stay Home and not gather in large groups.

Medical Director's Report to the Board of Health H. Lauren Vogel, D.O., M.P.H. - May 2020 Pediatric Multi-System Inflammatory Syndrome, Kawasaki Disease and Cytokine Storm

Previously it was believed that children with covid19 infection suffered mild symptoms and had an uncomplicated recovery. In April 2020, children were being admitted to the ICU in France with characteristic symptoms associated with covid19 infection.¹ Additional similar cases were identified in the UK and in early May in New York and Boston. The emerging syndrome was coined "Pediatric Multi-System Inflammatory Syndrome Potentially Associated with COVID-19 (PMSIS).²

Symptoms of PMSIS share many of the clinical findings associated with pediatric Kawasaki Disease (KD). This includes significant cardiac involvement. Both diseases share a common etiology with the syndrome of cytokine storm which has been associated with patients suffering from severe covid19 infection.

Kawasaki syndrome (KD), also known as Mucocutaneous lymph node syndrome, was first reported in 1967 in Japan as an acute febrile illness of unknown cause that most commonly affected children under age 5. The disease has been recognized as a rare post-infectious complication of viral infection. A rare case of adult-onset KD which was associated with Coxsackievirus A4 was reported in 2015. Coxsackie A and Coronavirus infections have been implicated in the KD syndrome as early as 2012.

Symptoms include persistent fever of 5 or more days, peripheral edema of hands and feet, maculopapular rash and erythema of the mouth, lips and palms with skin desquamation of the peripheral limbs, mucous membrane involvement with fissured tongue and conjunctivitis and enlarged cervical lymph nodes. The most serious complication has been cardiac involvement with coronary artery dilation and aneurysms. KD is the most common cause for acquired heart disease in the US today.³

To understand the syndrome of cytokine storm (CCS) requires a basic understanding of how the human immune system works. When exposed to a foreign element, such as a virus or even a splinter, the immune system becomes activated and sends inflammatory cells to the site of the infection. Cytoclines are signaling chemicals that are secreted from inflammatory cells that initiate and upregulate inflammatory reactions and immune response.⁵

The immune response is usually balanced and once the offending agent has been neutralized, the immune system returns to a passive baseline. Cytokine storm (CCS) is an abnormal response within immune system. When an imbalance occurs these cytokines cause a disease in itself making the original disease worse with more inflammation, tissue destruction and sometimes, shock and death.

With some infections, a healthy immune system may be a liability as opposed to an asset. It is believed that cytokine storms were responsible for the disproportionate number of healthy young adult deaths during the 1918 influenza pandemic, during the 2003 SARS epidemic and human deaths that occurred in association with the H5N1 bird flu. A genetic disposition for invoking a hypermedia response has been proposed. It is possible that vitamin D deficiency may predispose to the hyperimmune repsonse.

Information gained from studies of the COVID-19 epidemic in China found that a hyper inflammatory syndrome that was characterized by elevated levels of reactive cytokines was associated with multi organ failure and death. Pulmonary involvement was noted in over 50 percent of the severely affected patients. It was suggested that hyper-inflammation was the cause for increased patient mortality. ⁶

Although the etiology of KD remains unclear, the cases associated with Coxsackie A and covid-19 suggest that viral infection may trigger a hyperimmune response in susceptible subjects. The hyperimmune response (cytokine storm) in adults usually occurs during the second week of infection. In the children with KD and covid19, the response becomes prevalent later.^{7,8} For patients with PMSIS, the hyperimmune response is present earlier and the complex is usually not associated with enlarged cervical lymph nodes and presents with more gastrointestinal symptoms.

The possibility that KD, PMSIS and Cytokine storm are manifestations of the same hyperimmune syndrome cannot be ignored. Treatment options differ among the syndromes however. In KD, aspirin is administered to prevent the cardiac complications and this therapy is being used in the current management of PMSIS. NSAIDs have not shown benefit in the management of CCS however.⁵ Immunoglobulin is beneficial for KS but has not shown benefit in covid19 management. Recovery plasma has shown benefit in the management of severe covid19 infection. It appears that all three entities are post-infectious complications of a viral illness, in these cases, covid19.



Comparison Influenza vs COVID-19 (US)

When someone says COVID-19 is just like the "flu"; The incidence of influenza in 2019-20 is 22 times that of Covid19 (May 18, 2020) but the comparative death rate for COVID-19 is 66 times more deadly than for influenza.

Updates:

- AAA staff have kept up with an increase in demand for services and incoming phone call volume while continually connecting with participants. Multiple new referrals have come in for both our Community Living Program and Services to Victims of Elder Abuse Program. We've begun to ask participants questions about their access to technology, internet reliability and their preferences related to connecting virtually as it seems this will be our "normal" for a while. We've also been busy distributing AASA-issued PPE to our providers and vendors in an effort to protect direct care workers and staff.
- 2. The 2nd quarter Services to Victims of Elder Abuse program report is attached. You will see we've been busy and much of Victim Specialists' work has surrounded criminal justice system interactions & advocacy. Third quarter numbers will, I predict, be much higher as today alone our Victim Specialists have opened 4 new participants... a record number for one day! You may recall that our agency was selected to present a session on our VOCA project at our National Association of Area Agencies on Aging Conference & Tradeshow. We were just notified that the conference has been canceled... We are quite bummed but we will apply again next year!
- I'm excited to share that our region will receive another allocation of shelf-stable "Quarantine Boxes" (Qboxes) from our state agency. We are working locally to coordinate efforts with the Branch Area Food Pantry, St. Joseph County United Way, Community Action and St. Joseph County COA. This second round of Qboxes will come mid-June.

...And, there is MORE FOOD on the way!

I've attached a flyer for another new program initiated during the pandemic! USDA Farmers to Families Food Boxes will be delivered weekly by Van Eerden Foodservice starting on 5/22/20. Hundreds of boxes of fresh fruits, vegetables and dairy products are intended to further support older adults and kinship families/grandparents raising grandchildren during the crisis. We, again, are coordinating efforts with our amazing partners as mentioned above. There has been no cost to AAA's or community partners for any of these boxes... just staff time to coordinate, deliver and store them.

- 4. We have received all of the special allocations we've been anticipating through the CARES Act and Families First Coronavirus Act. Because we don't have all of the guidance needed to proceed with amendments, we are not able to present them to the BOH this month. We will work with the finance team to bring them forth in June. We've been having in-depth discussions with all providers about their needs, creative ways to reimburse their monumental efforts and unique client/participant needs that have arisen as a result of the pandemic. Stay tuned...
- 5. Typically, we would also have a draft Area Implementation Plan for your review this month. Due to the pandemic, AASA has extended our current FY2020 AIP's for 12 months. This means they've revised instructions and will be issuing additional guidance soon! During the 5/21/20 Advisory Committee Meeting, we reached consensus that a Zoom video/conference call would be used to conduct public input on the Plan when it is drafted. This means June will be a very busy month for AAA business. We look forward to sharing the draft and, as always, it will include feedback and input from our community partners and providers to assure our continuum of services meets our unique needs across Branch and St. Joseph Counties.

Personal Health and Disease Prevention: May 28th, 2020

Communicable Disease:

As of May 20th, we have responded to approximately 1,900 Covid-19 confirmed or related cases. Currently, we are tracing approximately 150 people.

We are welcoming three volunteers to our BHSJ team who will help us with contact tracing calls while we prepare to direct our staff to other priorities.

Immunizations/STI/HIV:

We held our first immunization clinic on May 18th at the Branch location since closing our doors. We took proper cautionary measures to make sure we were continuing to social distance as much as possible and ensure the safety of our staff and patients. We asked that patients wait outside in the vehicle until we called them in for screening. They were also required to wear a mask as long as of age for children and medically able to do so. We only allowed 1 family (1 adult/1 child) in the lobby area and 1 family in the immunization room at a time. Our schedule was small, we were able to see 4-5 patients that day. We will continue to "test" with small clinics by appointment only as we learn to adjust to a new routine.

Women, Infant, and Children (WIC):

WIC services continue to be held via phone. We put a team together to really focus on WIC clients. As you can see from our stats, this program has been thriving! Per our most recent WIC notice, we are able to continue phone communication with clients through June 30th, 2020.

Children's Special Health Care Services (CSHCS), Lead, and Hearing & Vision:

Terri Penney, our CSHCS Supervisors worked with a University of Michigan pediatric audiologist, they were able to go out into our community for this first time in quite some time. They delivered 8 sets of hearing aids to some anxiously awaiting children. They were also able to see 4 other kids that needed new hearing aid molds and get those replaced. Specialists offices are starting to open up now and we are working on getting appointments set back up for our CSHCS children.



This reflects WIC clients who have enrolled and are using their WIC benefits. These are the numbers that our funding is dependent upon. We need to maintain a caseload at 97% or greater than our assigned caseload of 5,700 participants. This means that we need to have a caseload of at least 5,529 clients each month that are using their WIC benefits to remain funded at our current level. This report runs two months behind, so numbers are not accurate for the month prior to the month the report was run.

Food Service Sanitation

On May 11, we were very pleased to bring back the last two EH staff members who were laid off. The food program sanitarians have been very involved with Covid-19 response. They have been conducting interviews with long term care facilities and adult foster care homes. The interviews are very in-depth and cover a long list of protocols and actions that are essential for them to control the spread of coronavirus in congregate living facilities.



Our food staff is also currently working on drafting a guidance document for restaurants in regard to safe practices as we prepare for the reopening of facilities for dine-in operations. Once the document is completed, we will post it on our website for all of our facilities to access.

Well and Septic

Our field sanitarians are once again processing well and septic permits in response to the governor reopening construction. There was quite a backlog of work that accumulated during the shutdown in all three counties, so the sanitarians have been very busy trying to catch up. Typically, this time of year we would be beginning to doing swimming pool, campground and children's camp inspections but these activities are still on hold. I have been receiving phone calls from campground owners and campground patrons on a daily basis wanting to know when the campgrounds are going to open or why the health department is not allowing them to open. People are getting very anxious to return to "normal" activities and this is certainly understandable. The focal point of my conversations has been on educating the people on the public health concerns with opening up facilities that could potentially accelerate the spread of Covid-19.

General Programs

This year we will once again be participating in the Vector Borne Disease Surveillance and Prevention (VBDSP) grant project that is sponsored by the Michigan Department of Health and Human Services. We have hired three vector technicians to carry out the grant requirements in each of our counties. We were very fortunate to have two of the technicians from last year return. The remaining position was filled with one of our former sanitarians (Tony Headley) who retired from our agency last April. This year's grant will again focus on trapping and identifying mosquitos with the focus on the invasive species that carry Zika virus. The staff will also be conducting tick drags with an emphasis on identifying deer ticks which are associated with Lyme Disease.

Food Inspection Codes:

P-This indicates a priority violation which is a violation which includes a quantifiable measure to show control of hazards such as cooking, cooling, reheating and handwashing. It is in general terms a violation that can potentially lead directly to an illness.

Pf-This is a priority foundation violation which is a violation that supports a priority violation. For example, the lack of soap or towels at a handwash sink is a Pf. This supports the priority violation of not washing hands.

C-This is a core violation-This is an item the usually relates to general sanitation, operational controls and maintenance of facilities and equipment.
