YTD: Divided by # weeks paid x 52 weeks

Ways to Calculate Total Annual Income Use past month (30 days) check stubs for income verification

Gross Income: Most recent IRS 1040 (Net Income for Farm and Self-Employed

workers)

Weekly x 52 weeks

2 Checks per month 1 pay stub x 24

No Income: Review "No Income" questions to determine if part of another family. If not, record \$0 annual income. Record Self-Declared/ Verification.

Every 2 weeks x 26 weeks

Monthly x 12 months

Adjunct Eligibility (Medicaid, Food Stamps or FIP): Verify current eligibility. Then client can self-declare income.

Sudden Change in Income:

Today's Income x 52 weeks

Remember! You can use 1040 tax with W-2 forms until the next one is filed for documentation.
